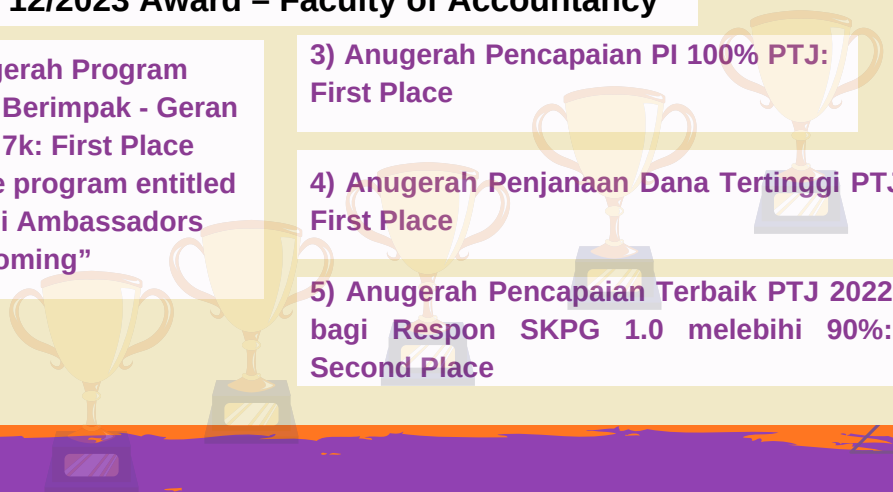

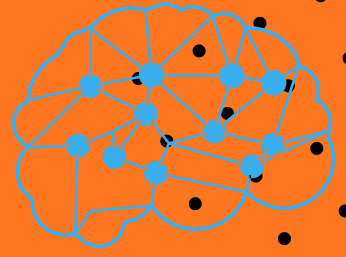
WAQF CORNER

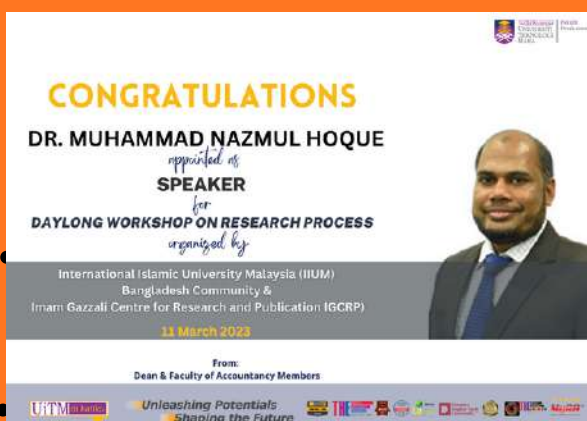
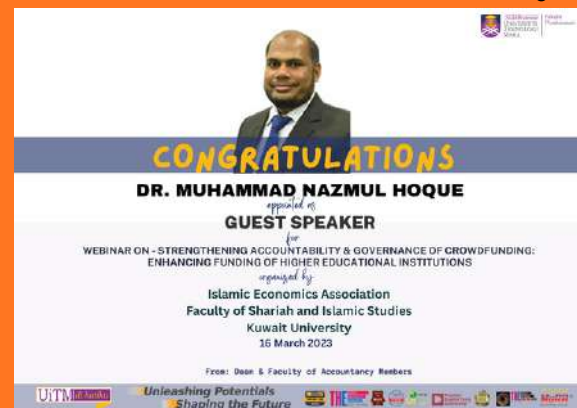

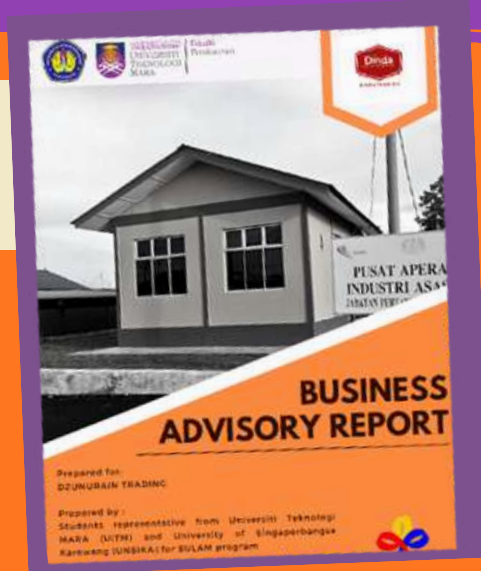
The MoU will facilitate sharing of information between parties involved and the development of common line of action in achieving its objectives.

Service Learning Malaysia- University for Society (SULAM) International has been developed with the involvement of UiTM international strategic partners and Faculty of Accountancy's students taking the Integrated Case Study (MAF671) course.

On December 2022, the eSULAM international was conducted jointly between Small-Medium Entrepreneurs (SMEs) from Indonesia (Mille Crepes Sinok Karawang) and Malaysia (Dzunurain Trading).
