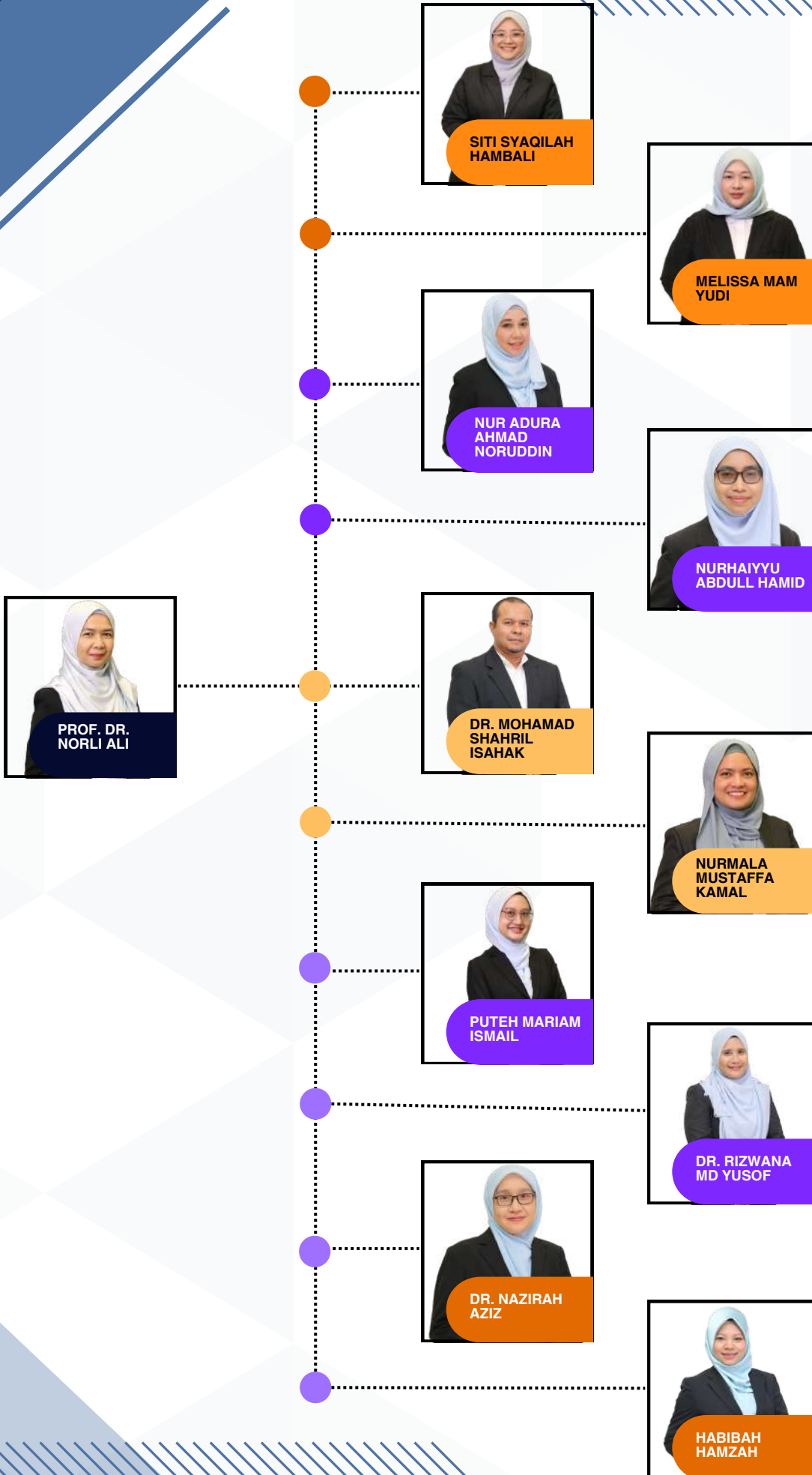

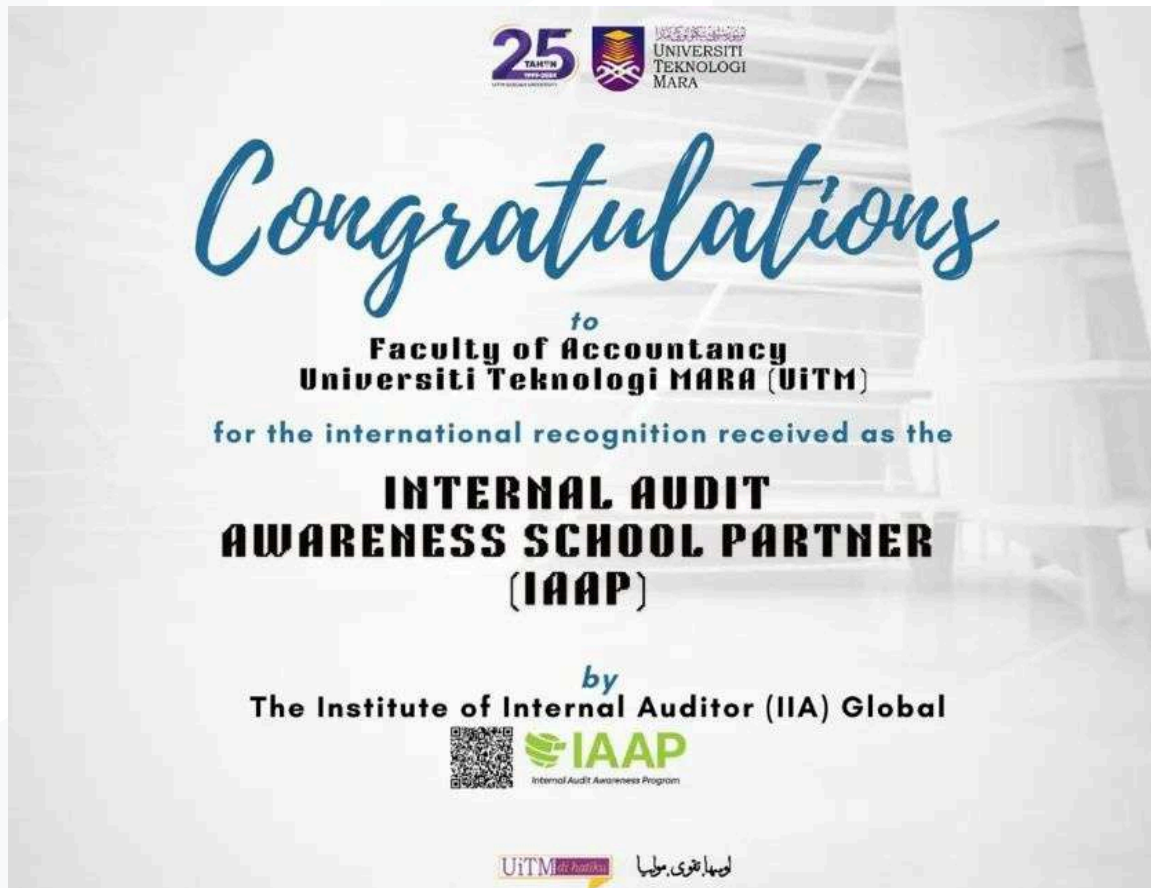

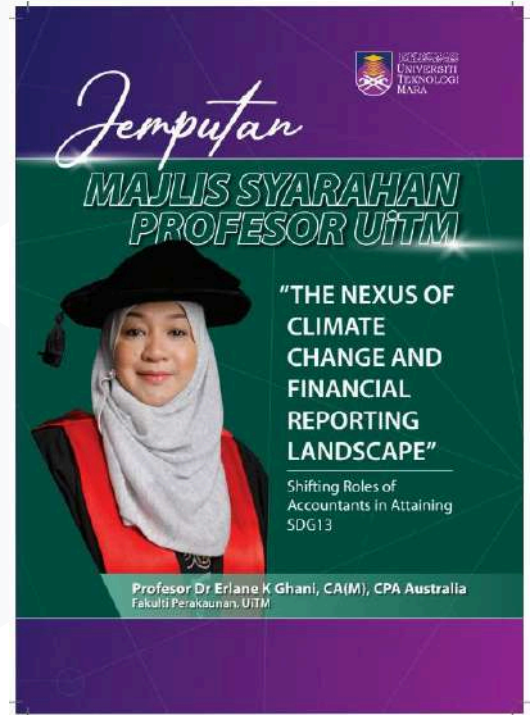

The 1 Student 1 Gadget program

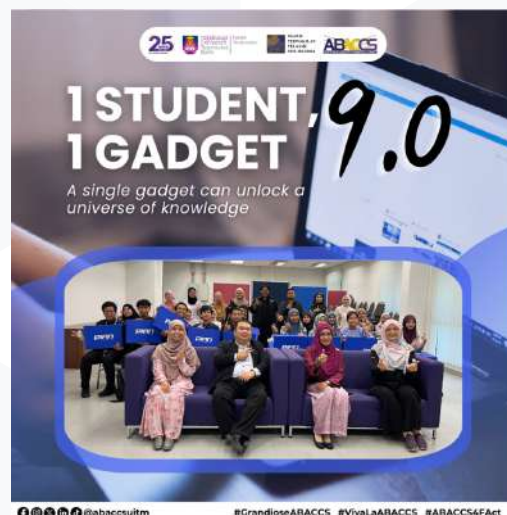

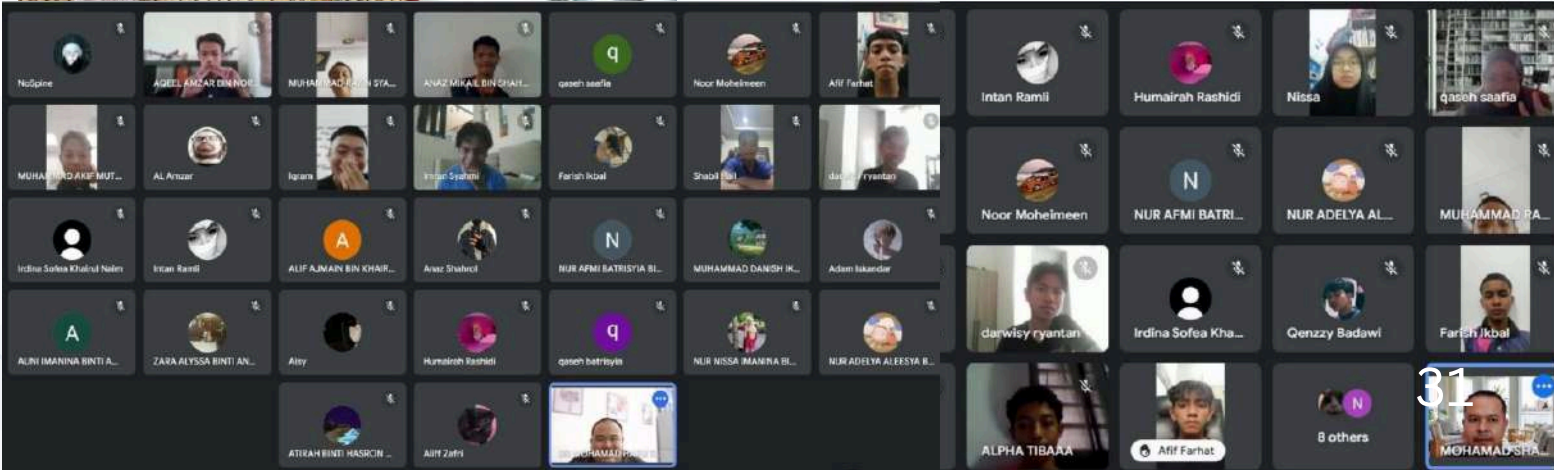

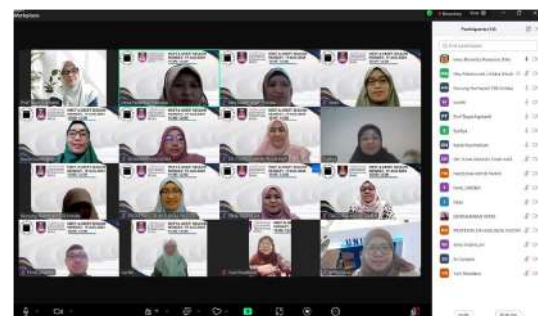
