UNIVERSITY :

- Passed SPM / equivalent with at least 5 (FIVE) credits including Bahasa Melayu/Malaysia.
- Pass in History subject.

PROGRAMME :

- Diploma in Accountancy/Diploma in Accounting Information Systems from UiTM or from other higher education institutions recognised by the government of Malaysia with a CGPA of at least 3.00 **OR**
- A Degree in Accountancy/Finance/Investment from UiTM or from other higher education institutions recognised by the government of Malaysia with a CGPA of at least 2.75 **OR**
- Final semester CAT/full CAT result from UiTM or other higher education institutions recognised by the government of Malaysia with an average score of 60% **OR**
- UiTM Foundation/UM Science Foundation/Matriculation with a GCPA of at least 3.50 with minimum B+ in Mathematics and MUET Band 3 **OR**
- A Level with at least A in 2 (TWO) subjects including Mathematics.
